

# SINGLE ORGANISATIONAL END USER LICENCE AGREEMENT TO USE UK-DMC2 SATELLITE PRODUCTS



This is a legally binding agreement between the End User, and DMC International Imaging Limited ("DMCii"). DMCii has the right to licence worldwide remotely sensed DMC Data acquired by DMC satellites and DMCii derivative Products.

## 1. DEFINITIONS

"Data" or "Imagery Data" means the UK-DMC2 satellite raw image data, as downloaded from the spacecraft

"Derived Products" or "DP" means any product or information developed by the End User from Imagery Data or a VAP, which does not contain any Imagery Data and is irreversible and uncoupled from the source Imagery Data or VAP.

"Distributor" means DMCii's authorised distributor within the Territory through which the End User Licence was procured, or DMCii, where the sale has been completed directly.

"DMCii Data or Products" means Imagery Data and/or Value Added Products provided to the End User under the terms of this Licence

"End User" means the organisation or individual who will use the DMCii Products strictly in accordance with the terms of this Licence. This will include contractors and consultants for use on behalf of the organisation or individual.

The "End User" shall be defined by one of the following, who has accepted the terms of the EULA.

- An Individual, or any one entity or equivalent to any of the entities listed below.
- A Company or corporation, not including subsidiaries, affiliates or representative offices
- An office or department of a civilian federal, state, provincial, county or local agency
- A non-governmental, educational or non-profit organisation
- An office or department within an international organisation, institution, or agency, including the United Nations or European Union

"Value Added Products" or "VAP" means any product(s) or information developed by the End User or made available directly by DMCii under the terms of this Agreement, which contains Imagery Data. VAP are products from which the original Imagery Data values can be retrieved;

## 2. LICENCE

This DMCii Single Organisational Licence Agreement for Data or Products ("Licence" or "Agreement") permits you to use the DMCii Products acquired under the terms of this Licence on computer systems owned or leased by the licenced entity provided that such DMCii Data or Products may not be accessed by users outside of the licenced entity except as specified in Article 3 below. The licenced entities are those, which DMCii has licenced. By accepting a quotation for the supply or for the download/receipt of DMCii Data or Products, agreeing to these terms in writing, the End User accepts and agrees to be bound by the terms of this EULA.

## 3. COPYRIGHT, USES and RESTRICTIONS

The DMCii Products are owned by DMC International Imaging Limited or its suppliers and are protected by English copyright laws and international treaty provisions. Therefore, you must treat the DMCii Products like any other copyrighted material except that you may make copies of and/or provide access to the DMCii Products solely for the purpose of facilitating use by the licenced entity(s). You may copy the written materials accompanying the DMCii Data or Products for use by the licenced entity(s).

You may analyse, process, and display the licenced DMCii Data or Products and may make such DMCii Products and the results of such analysis or processing available to employees of your organization. You may make an unlimited number of film, print and Internet Display copies of the DMCii Products provided that: (1) all copies must include a copyright notice prominently displayed in or adjacent to the DMCii Data or Products in the format presented below; (2) you may not sell any copies made for such

purposes; and (3) you prohibit as far as possible this material from being downloaded or screen captured by individuals or organizations located outside of the licenced entity.

You may prepare Derived Products based upon the licenced DMCii Products and publish, sell or distribute such materials, but only if such materials do not reproduce in any way the licenced DMCii Data or Products.

You may not rent or lease the DMCii Data or Products, but you may transfer your rights under this Agreement on a permanent basis provided you transfer this Agreement, the DMCii Data or Products, and all accompanying written materials and retain no copies, and the recipient agrees to the terms of this Agreement. The transfer of possession terminates your licence from DMCii. The transfer should be notified to DMCii.

When reproducing DMC imagery in print or internet display for any of the purposes stated in this Agreement the logo of DMCii should be displayed and you shall include one of the following notices as appropriate for the relevant satellite. All copyright notices will be in following format(s):

"© DMCii 20.. (year of production), XXX." for DMCii Data.

"© DMCii 20.. (year of production) " for VAP produced by DMCii.

"UK-DMC-2 image copyright (c) 'year' DMCii"

The logo of DMCii will be supplied by DMCii as an electronic file on request.

#### **4. LIMITED WARRANTY**

DMCii will use all reasonable endeavours to ensure that any DMCii Data or Products provided to you conforms to the DMCii Products requested and that the medium in which the DMCii Data or Products delivered is free of physical defect. If any DMCii Data or Product does not meet the foregoing standards, your sole and exclusive remedy will be to return such DMCii Data or Products to DMCii through the Distributor within thirty (30) days of your receipt thereof. If you return the DMCii Data or Products within such period and if DMCii reasonably determines that such Data or Products, at the time they were delivered to you, failed to meet such standards, DMCii will replace or repair the DMCii Data or Products and return it to you.

Except as provided in the preceding paragraph, any DMCii Data or Products licenced pursuant to this Agreement are provided without warranty of any kind, whether express or implied, including implied warranties of merchantability and fitness for a particular purpose, even if DMCii is advised of such purpose. DMCii's liability with respect to any such Data or Products will, in any case, be limited to replacement or repair of the DMCii Data or Products. In no event will DMCii be liable to you for any special or consequential damages, including lost profits resulting from any defect in any DMCii Data or Products or any delay in delivery.

#### **5. OTHER**

This Agreement shall be governed by English law. DMCii retains all rights not expressly granted. This licence is effective until terminated. It may be terminated by you by destroying all copies of the DMCii Data or Products. It will terminate automatically if you fail to comply with any of the terms of this Licence, and on any such termination you will destroy all copies of the DMCii Data or Products.
